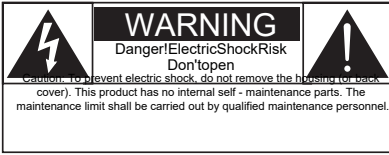

SAFETY INSTRUCTIONS

WARNINGS AND PRECAUTIONS

Please note the following safety warning signs



Note: To prevent electric shock, do not remove the enclosure (or back cover). There are no self-maintenance parts in this product. The maintenance limit shall be carried out by qualified maintenance personnel.



This symbol indicates that there is a high voltage inside. Any contact with internal parts of this product is dangerous.



This sign is to remind you that there is important operation and maintenance matters comes with this product.

Note: To prevent electric shock, please fully insert the plug into the socket in the width direction.

To prevent damage from causing fire or electric shock, do not expose the product to rain or a moist environment.

Power sockets should be installed near the product and should be easy to use.



Read and follow these instructions when connecting and using public information displays:

- Unplug the display if you are not going to use it for a long period of time
- If you need to clean the monitor with a damp wipe cloth, remove the plug first. Wipe the screen with a dry cloth only after the power is turned off, but do not use alcohol, solvent or liquid containing ammonia.
- If you have followed the instructions in this manual, but the monitor still cannot work properly, please consult the maintenance technician.
- The cover should only be opened by qualified maintenance personnel.
- Keep the monitor out of direct sunlight and away from stoves or other heat sources.
- Do not let the monitor contact with any oil stains, plastic parts may be aging and crack.
- Remove anything that could fall into the vent or interfere with the heat dissipation of the display electronics.
- Do not block the ventilation holes on the cabinet.
- Keep the monitor dry. In order to avoid electric shock, do not place the product in a humid environment or be exposed to rain.
- If the power cable is directly removed, please wait 6 seconds and then plug the power cable back in to ensure normal operation.
- In order to avoid electric shock and permanent damage to the product, do not place the product in an overly humid environment or be exposed to rain.
- When placing the monitor, ensure that the power plug and socket are easy to use.

Important Safety Instructions

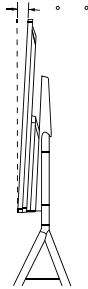

1. Unboxing and installation

1.1. Unboxing

- •The product is packed in a carton with standard accessories.
Any other optional accessories will be packed separately.
Considering the size and weight of this monitor, it is recommended that two people carry this monitor.
After opening the box, please verify that all parts are included and in good condition.

1.2. The contents of the packing case

Please confirm that the following items are included in the packing box:

- Display
- User manual
- Warranty card
- The power cord
- Stylus pen
- Screw accessory kit

Note:

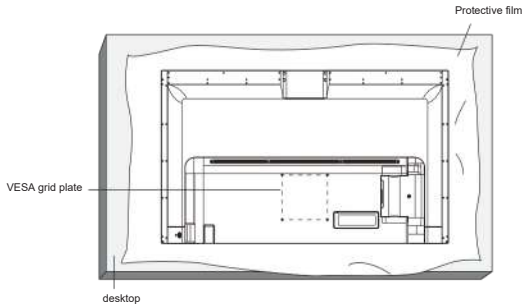
- For all other areas, the power cord used should match the AC voltage of the power outlet, comply with the relevant safety regulations of the country/region and be certified.
- You can keep the packing box and packing materials for future transportation of the monitor

1.3. Precautions for installation

- Due to the high power consumption, always use the plug exclusively designed for this product. If an extended line is required, please consult your service agent
- The product should be installed on a flat surface to avoid tipping. The distance between the back of the product and the wall should be maintained for proper ventilation. Avoid installing the product in the kitchen, bathroom or any other places with high humidity to avoid shortening the service life of the electronic components.
- The product can normally only operate under 5000m in altitude. If above 5000m, there may be something unexpected occur

1.4. Hang it on the wall

To mount this monitor to a wall, the standard wall-mount kit is recommended. We recommend that you use assembly boards that meet **TUV-GS** and/or **UL1678** standards.



1. Lay the protective film (which wraps around the monitor when packing) on the table, placing the monitor face down on the protective film to avoid scratching the surface of the screen.
2. Make sure you have all the accessories you need to install this monitor (wall rack, lifting rack, desktop base, etc.).
3. Follow the instructions that came with the base assembly kit. Failure to follow the correct assembly steps may result in damage to the equipment or injury to the user or installer. The product warranty does not cover damage caused by improper installation.
4. For the wall mount kit, use the **M6** assembly screw (the length exceeds the thickness of the assembly frame by **10 mm**) and tighten the screw.

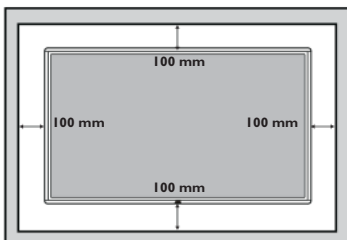
Be careful:

Prevent the display from falling:

- For wall-hanging or hoisting cases, we recommend the use of commercially available metal assembly racks for mounting the monitor. For detailed installation instructions, see the guide that came with the assembly rack.
- To reduce the possibility of the display falling and causing injury and property damage in the event of an earthquake or other natural disaster, consult the assembly rack manufacturer to confirm the installation location.

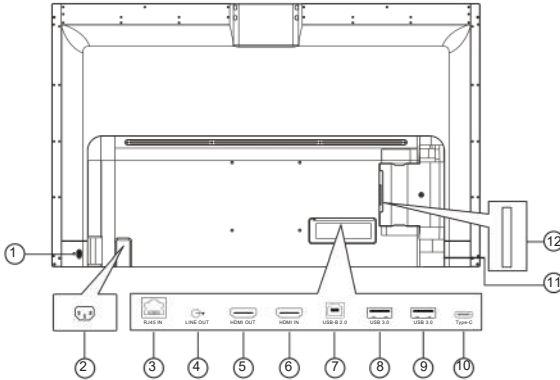
Ventilation requirements for enclosed Spaces

For normal heat dissipation, sufficient space should be left between the surrounding items, as shown in the figure below.

① OK / Power

Turn the power on or off.

② AC Input

AC power input from wall sockets.

③ RJ45 IN

Wired network connection.

④ LINE OUT

Output audio to an external AV device.

⑤ HDMI OUT

HDMI Video/audio output.

⑥ HDMI IN

HDMI Video/audio input.

⑦ USB-B 2.0

Connect the touch control of the PC.

⑧ USB 3.0

Connect the USB storage device.

⑩ Type-C

USB storage device connected to TYPE-C interface

⑪ USB 2.0

Connect the USB storage device.

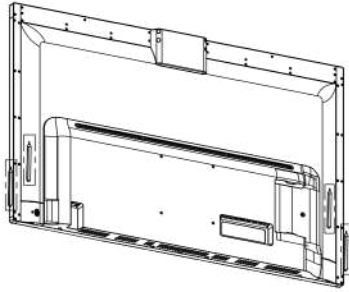
⑫ OPS

Connect the OPS device.

The pen can be adsorbed to the rear iron backplane position (as shown)

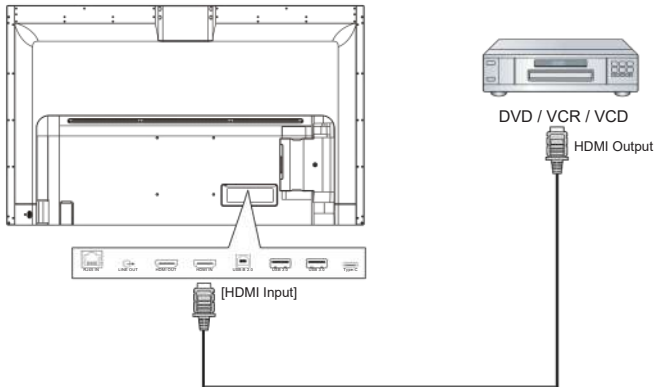


It is adsorbed on both sides of the frame or the rear iron back plate

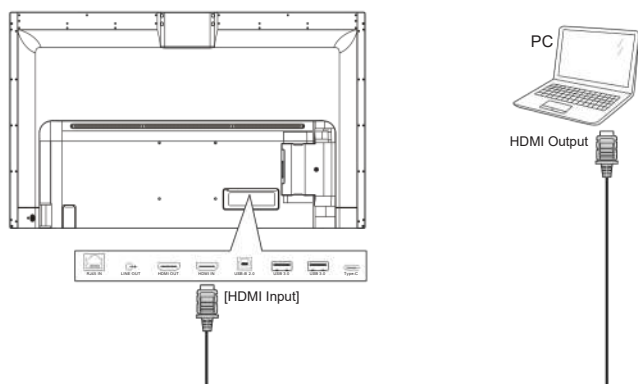

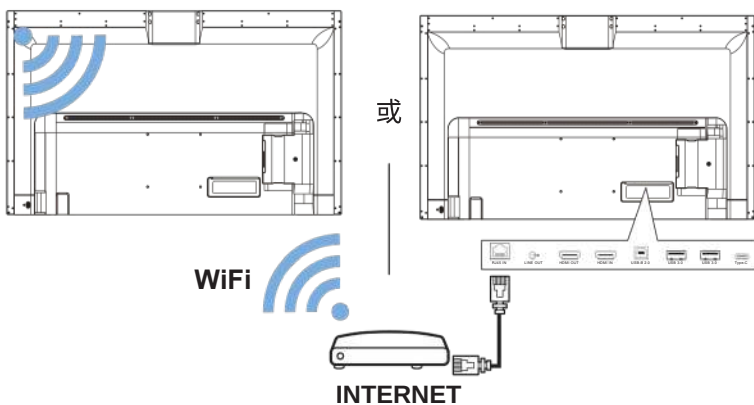

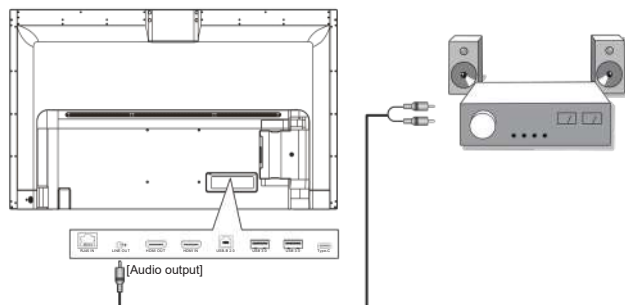

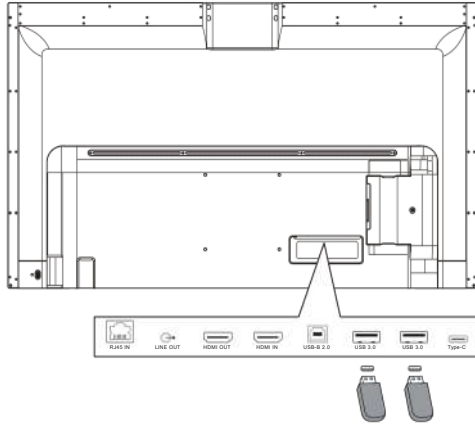

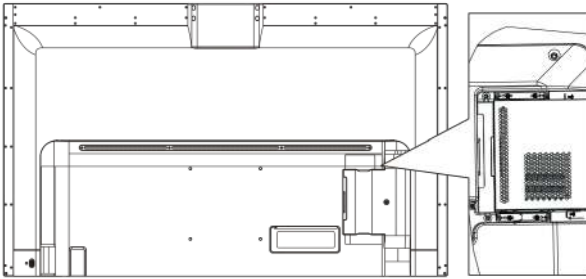

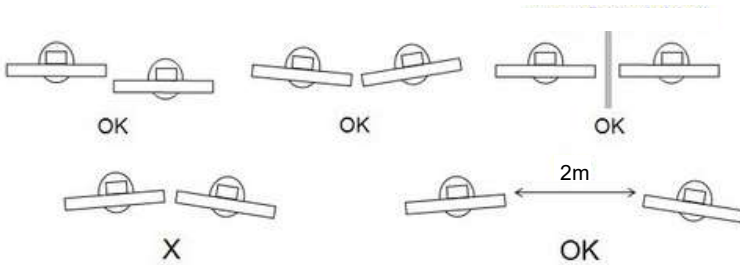
3.6. Connect the OPS

Insert the OPS, adjust and lock the small iron piece, and then lock the OPS.



4. Touch operation

- Avoid scraping the screen with sharp objects. You can use the attached stylus to touch.
- Do not expose the screen to bright light, spotlights or floodlights.
- Do not install the product near Windows or glass doors, otherwise direct sunlight may affect the touch effect.
- To avoid interference between the screens, do not place the two touch screens side by side, as shown below.



5. Cleaning and troubleshooting

5.1. Cleaning

Caution when using the display

- Do not bring your hands, face or objects close to the ventilation holes of the display. The top of the display is usually very hot due to the high temperature of exhaust air being released through the ventilation holes. Burns or personal injuries may occur if any body parts are brought too close. Placing any object near the top of the display could also result in heat-related damage to the object as well as the display itself.
- Be sure to disconnect all cables before moving the display. Moving the display with its cables attached may damage the cables and thus cause fire or electric shock.
- Disconnect the power plug from the wall outlet as a safety precaution before carrying out any type of cleaning or maintenance procedure.


Front panel cleaning instructions

- The front of the display has been specially treated. Wipe the surface gently using only a cleaning cloth or a soft, lint-free cloth.
- If the surface becomes dirty, soak a soft, lint-free cloth in a mild detergent solution. Wring the cloth to remove excess liquid. Wipe the surface of the display to remove dirt. Then use a dry cloth of the same type to dry.
- Do not scratch or hit the surface of the panel with fingers or hard objects of any kind.
- Do not use vaporous substances such as insert sprays, solvents and thinners.

Back panel cleaning instructions

- If the cabinet becomes dirty, wipe the cabinet with a soft, dry cloth.
- If the cabinet is extremely dirty, soak a lint-free cloth in a mild detergent solution. Wring the cloth to remove as much moisture as possible. Wipe the cabinet. Use another dry cloth to wipe over until the surface is dry.
- Do not use any solution containing grease to clean plastic parts. Plastic parts may be aged and cracked when exposed to grease.
- Do not allow any water or detergent to come into contact with the surface of the display. If water or moisture gets inside the unit, operating problems and electrical and shock hazards may result.
- Do not scratch or hit the cabinet with fingers or hard objects of any kind.
- Do not use corrosive substances such as insert sprays, solvents and thinners on the cabinet.
- Do not place anything made from rubber or pvc near the cabinet for extended periods of time.

5.2. Troubleshooting
